



INSURANCE AND DOCUMENTS REQUIREMENTS

You are hereby notified to provide MICHAEL GRANT CONSTRUCTION, INC. the following:

Insurance Requirements

A certificate of Insurance meeting the requirements outlined Subcontractors Agreement or Subcontractors Work Authorization herein attached. Insurance Certificate must have MICHAEL GRANT CONSTRUCTION, INC. named as the Certificate Holders. Please read the insurance requirements and contact the Corporate Office if you cannot meet the requirements or have questions. Also, listed below are the insurance requirements per Subcontractor's Agreement and/or Subcontractor's Work Authorization:

General Liability

General Aggregate: Not less than \$1,000,000, Completed Operations Aggregate: Not less than \$2,000,000, Each Occurrence Personal injury, advertising injury bodily injury, and property damage: Not less than \$1,000,000 Combined Single Limit. MICHAEL GRANT CONSTRUCTION, INC. must be named as an "Additional Insured", "30 Day Notice of Cancellation" clause, and a "Waiver of Subrogation" in MICHAEL GRANT CONSTRUCTION, INC.'s favor must be included on the policy.

Worker's Compensation

Worker's Compensation policy including Employers' Liability in an amount equal to at least \$500,000 for Each Accident, Each Employee, and Policy Limit. A "30 Day Notice of Cancellation" clause and a "Waiver of Subrogation" in MICHAEL GRANT CONSTRUCTION, INC.'s favor must be included on the policy.

All Insurance carriers/companies must be rate A-V or better, as indicated in the most current A.M. Best Rating Guide.

Note: The above documentation is only a general outline of insurance coverage requirements for subcontractors. Please refer to the "Subcontractor Agreement" or Subcontractor's Work Authorization for further clarification and/or additional insurance requirements.

W-9 Request for Taxpayer Identification Number and Certificate, filled out, signed and returned to MICHAEL GRANT CONSTRUCTION, INC. corporate office.
